
In these series of talks we would discuss different issue around complex models. In particular, regression models in which the number of unknowns is larger than the number of observations.

The key to the feasibility of estimation is a search for a solution is an almost compact set. The standard assumption is that the solution is with a relatively small number of non-zero coefficients, and can be obtained using a convex penalty function, in particular the L1 norm of the vector of coefficient: The so-called Lasso.
