3. Processing purposes and legal basis

Wirtschaftswissenschaftliche Gesellschaft an der Humboldt-Universität zu Berlin e. V. (WWG) processes the following personal data:

- For the purposes of managing members and fees, the surname, forename(s), postal address and other contact details (email addresses, telephone numbers) and bank details are processed. The legal basis for this is Art. 6 para. 1 sentence 1 lit. b) of the GDPR.
- In addition, when visiting our website https://www.wiwi.hu-berlin.de/de/wwg, anonymised technical data and information are collected and stored in the log files on the Humboldt-Universität zu Berlin servers. This data includes the browser types and versions used, the operating system used by the accessing system, the website from which an accessing system is directed to our website [otherwise known as "referrers"], the subpages which are controlled by an accessing system on our website, the time the website was accessed and the IP address omitting the last digit for the purposes of anonymisation. 4. Retention period

- The data necessary for managing members and fees (surname, forename(s), date of birth, postal address, email addresses, telephone numbers and bank details) shall be deleted 6 months after membership of the association has ended.
- The log data mentioned under point 3 shall be deleted after one week.

5. Data subject rights

Regarding the collected data, the association member has right of access (Art. 15 GDPR), right to rectification (Art. 16 GDPR), right to erasure (Art. 17 GDPR) or restriction of processing (Art. 18 GDPR) as well as a right to object to processing (Art. 21 GDPR) and a right to data portability (Art. 20 GDPR). The association member has the right to revoke his/her declaration of consent in accordance with data protection law at any time (using the above contact details). This will not affect the legality of any processing done between the moment consent was given and the moment it was revoked. The association member also has the right to lodge a complaint with a data protection regulatory authority.

The search appliance "Mindbreeze", a paid software for conducting full-text searches, has been integrated into some Humboldt-Universität websites. "Mindbreeze" uses cookies that make it possible to analyse the behaviour of website visitors and how frequently they use the website. Only log files deemed relevant under data protection law are stored on a server in the Computer and Media Service of Humboldt-Universität.
